St. Vincent de Paul's Primary School believes it is important that students have exposure and interaction with web based technology and communication tools to participate in a global economy.

For this, we are asking for your written permission to the statements below:

- Use a St. Vincent de Paul's Primary School administered Google Apps for Education Account, which includes:

- I also acknowledge that in accordance with the Australian Privacy Act (AAP8), that data created using Google Apps for Education can be stored off site and overseas.

This cloud is a series of data centres that save the information, just like your computer at home would, for easy access. These data centers can be all around the world. The data is secure and can still only be accessed by the account holder the student, and St. Vincent de Paul's IT administrator but it is now a requirement of Australian law that you are aware and allow this)
